The womens restroom did not have paper towels. Please refill this as soon as possible.

Violation: IMPROPER CLEANING OF UTENSILS AND EQUIPMENT [HSC 114095-114099.5 & 114101-114119]

**Description/Corrective Action:** Observed the walk- in refrigerator to have water and food debris. A faint raw chicken

odor was observed. Please be sure to sanitize all surfaces to prevent microbial growth

and cross contamination. This was corrected on site. Thank you.

Observed both soda machines to have syrup build up, please wipe down the surface

with sanitizer to prevent cross contamination of soft drinks.

Observed the sanitizer bucket next to the registers to be below 200 ppm (ammonium).
